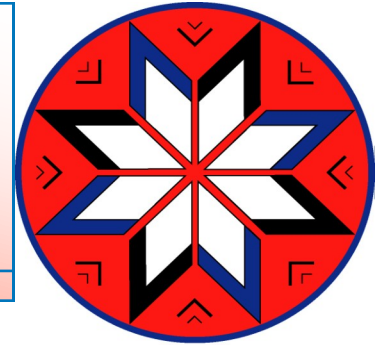

Tripartite Forum Welcomes New Executive Chair

Newly elected AFN Regional Chief Morley Googoo is the new Mi'kmaq • Nova Scotia • Canada Tripartite Forum Executive Chair. He replaces Rick Simon who served as Executive Chair since 2004.

In June, Simon relinquished his position as Regional Chief for Nova Scotia/Newfoundland for The Assembly of First Nations to accept a new role as Chief Executive Officer of Indian Brook First Nation. He served nearly six terms in 17 years as Regional Chief. Googoo was elected by Nova Scotia's and Newfoundland's Chiefs as the new Regional Chief in May.

the Aboriginal Services Coordinator for the Unama'ki College at the Mi'kmaq College Institute of Cape Breton University. The Education Committee is dedicated to assisting Mi'kmaq students and educators in early childhood to adult education.

The previous Education Committee co-chair, Leroy Denny, vacated the position following his election as Chief of Eskasoni First Nation.

On May 18, Minister John Duncan's title and department's name changed from Indian Affairs and Northern Development to Aboriginal Affairs and Northern Development Canada. INAC then became AANDC under the Federal Identity Program. The Minister's new title and the department's new name "better reflect the scope of the Minister's responsibilities with respect to First Nations, Inuit and Métis and is in keeping with practices of the department as, in recent years, the responsibilities of the department have expanded to include and better serve First Nations, Métis and Inuit peoples". The name changes does not impact the department's mandate or the Minister's statutory responsibilities.

The legal name of the department as set out in legislation still remains the Department of Indian Affairs and Northern Development, therefore it must continue to be used for documents such as agreements, contracts and legislation.

Annual General Assembly 2011

The Tripartite Forum held its 8th Annual General Assembly (AGA) at The Inverary Inn Resort on May 11-12 in Baddeck, Nova Scotia, with one of the highest attended assemblies ever. Nearly 100 Forum members and invitees attended the two-day meeting which highlights committee accomplishments and progress.

The AGA hosted a trade

show that included reps from various federal and provincial government programs, merchants, post-secondary institutes and Aboriginal organizations. Workshops included presentations on social media (Inverness County C@P Network Society, Mi'kmaq language, Tripartite Project Fund Committee, and Mi'kma'wey Debert. Presentations by Tripartite's Officials Committee and Kwilmu'kw Maw-klusuaqn Negotiation Office were also held.

Prizes were awarded to draw winners including Gord Johnson, Patricia Ellis, Pictou Landing Chief Aileen Francis, Farida Gabbani and Jarvis Googoo. Rick Simon was emcee for the AGA and elder Josephine Peck performed opening prayers.

Overall, the assembly was an enjoyable experience and the AGA committee did an amazing job with planning. See you in 2012!

Doctors Nova Scotia Youth Running for Fun Update

Doctors Nova Scotia extended its *Youth Running for Fun* program to First Nations schools and communities throughout the province. This year more than 1,100 students from First Nations schools across the province participated in the program, including 800 from grades one to nine at Eskasoni Elementary and Middle School.

On June 15, a celebration was held in Eskasoni to mark the milestone for both groups. In addition to Eskasoni, First Nations schools taking part in the running program to date have been Chief Allison Bernard Memorial High School, Membertou Elementary, Pictou Landing School, Potletekewey School, We'koqma'q Mi'kmaq School and also The Paqtnkek Community Centre.

Project Fund Update

The Project Fund Committee was very busy this spring and summer and received numerous funding proposals for a diverse group of events and programs. To date, 12 proposals were received and 10 were approved.

In April, five proposals were received and all were approved. The five proposals included Mawiomi 2011 (\$50,000.00), On-reserve daycare licensing research (\$10,000.00), *Pjila'si Mi'kma'ki* and MAPS administrative support (\$35,000.00), Kluskap Cave historical designation (\$12,574.00), and First Nations Active Measures Pilot Projects (Phase II) (\$45,100.00). Proposals were submitted by the Social and Culture and Heritage Working Committees. The meeting was held at The Confederacy of Mainland Mi'kmaq boardroom in Truro, NS.

At the Project Fund's second meeting on June 29 in Membertou, seven proposals from the Social, Sports and Recreation, and Education Working Committees

were submitted and five were approved. Doctors Nova Scotia *Running for Youth* Program (\$13,000) enters its second year while the *Healthy Living* project (\$12,000.00) was approved, along with Options for On-Reserve Daycare Licensing (\$7,205.21), Mi'kmaq Language Tool Kits (\$24,854.76), Curriculum Development Collaboration for training early childhood educators (\$33,066.00), and the Aboriginal Sports Summit (\$60,500.00).

Mawiomi 2011: Halifax International Pow-Wow

Membertou 400, the largest pow-wow in Atlantic Canada to date, hosted an estimated 80,000 people from Thursday, June 24, to Sunday, June 27, 2010, in Port Royal and Halifax. Following the incredible success of *Membertou 400*, Halifax played host to *Mawiomi 2011: Halifax International Pow-Wow* from Friday, July 1, to Sunday, July 3, 2011. The pow-wow was again held at The Halifax Common.

Halifax's random weather held-up for the three day celebration where visitors enjoyed sunshine, traditional drumming, singing, and dancing competitions. The free family event featured a vendor marketplace where traditional and modern First Nations crafts and products were sold, pow-wow competitions in drumming and dancing for all ages, and an interactive village with teepees, craft-making, story-telling, medicines and games. A new addition to this year's events was *Dinner In a Teepee* with local chief Ray Bear. At

night, the teepees, a prominent feature of *Membertou 400*, again illuminated The Common with beautiful and vibrant colours that delighted passers-by.
